Re: **Additional Materials Related to Staff Report Item No. 1 – Administrative Enforcement of Public Health Orders**

This memorandum provides an update to Agenda Item No. 1 for the City Council Special Meeting on Jan. 5, 2021. This update includes additional information related to the Police Department’s enforcement of the County Health Orders (CHO) over the New Year’s weekend.

The “Discussion” section of the Staff Report for Agenda Item No. 1 should include the following additional information as the fourth paragraph under Criminal Enforcement:

The Police Department conducted CHO enforcement over the New Year’s weekend, specifically to enforce the CHO at businesses within the city. Between Thursday, Dec. 31, 2020, and Sunday, Jan. 3, 2021, there were a total of 90 visits to 27 businesses that had cease and desist letters on file. During these visits, the Police Department found 54 violations at 19 establishments that required additional documentation, including crime reports and supplements to previously taken crime reports.
